



Wilks Brothers Stay Application Dismissed

CALGARY, AB, Dec. 2, 2020 /CNW/ - Calfrac Well Services Ltd. ("**Calfrac**" or the "**Company**") (TSX: CFW) advises that it has prevailed in Wilks Brothers, LLC ("**Wilks Brothers**") latest attempt to thwart the completion of Calfrac's Amended Recapitalization Transaction. That transaction is the subject of a final order of the Court of Queen's Bench of Alberta, approving the Company's Plan of Arrangement under the *Canada Business Corporations Act* ("**Final Order**"). The Court of Appeal also awarded Calfrac's costs in the matter.

On November 26, 2020, the Court of Appeal of Alberta dismissed Wilks Brothers' appeal of the Final Order.

Today, Wilks Brothers sought a stay from the Court of Appeal of Alberta. The stay would have prevented Calfrac from implementing the Company's Amended Recapitalization Transaction pending Wilks Brothers' seeking leave from the Supreme Court of Canada for such Court to hear an appeal of the Court of Appeal's decision. Wilks Brothers has also indicated its intent to appeal the Chapter 15 order received in the United States yesterday.

As a result of the Court of Appeal's dismissal of the stay application, Calfrac is not prohibited by any Court order from proceeding to implement the Company's Amended Recapitalization Transaction. The Company intends to complete the Amended Recapitalization Transaction as soon as is practicable, subject to the satisfaction or waiver of the other conditions to the implementation of the Plan of Arrangement. Calfrac will provide further updates in respect of the completion of the Amended Recapitalization Transaction as matters evolve.

Calfrac's common shares are publicly traded on the Toronto Stock Exchange under the trading symbol "CFW". Calfrac provides specialized oilfield services to exploration and production companies designed to increase the production of hydrocarbons from wells drilled throughout western Canada, the United States, Argentina and Russia.
